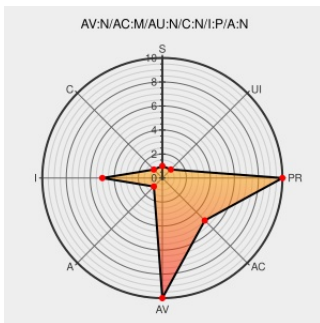

Certain versions of [Limesurvey](#) from [Limesurvey](#) contain the following vulnerability:

Cross-site scripting (XSS) vulnerability in admin/userriighthandling.php in LimeSurvey before 1.91+ Build 120224 allows remote attackers to inject arbitrary web script or HTML via the full\_name parameter in a moduser action to admin/admin.php. NOTE: some of these details are obtained from third party information.
