Description	Microsoft Internet Explorer 6 through 10 allows remote attackers to execute arbitrary code or cause a denial of service (memory consumption) via crafted HTML documents, as demonstrated by the 'javascript:' URL scheme. This vulnerability is caused by the way the browser handles the 'javascript:' URL scheme. The vulnerability is present in all versions of Internet Explorer 6 through 10.
