

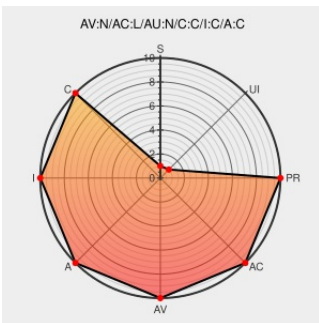

Intel Graphics Driver in Apple OS X before 10.9.4 does not properly restrict an unspecified OpenGL API call, which allows attackers to execute arbitrary code via a crafted application.
