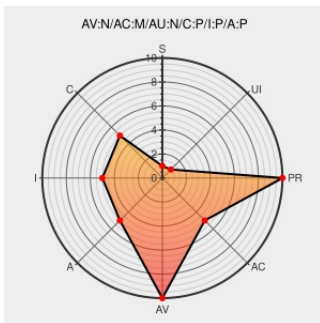

IOAcceleratorFamily in Apple iOS before 9.1, OS X before 10.11.1, and watchOS before 2.0.1 allows attackers to execute arbitrary code or cause a denial of service (memory corruption) via a crafted app.
