Certain versions of [Acrobat](#) from [Adobe](#) contain the following vulnerability:

Adobe Reader and Acrobat before 11.0.16, Acrobat and Acrobat Reader DC Classic before 15.006.30172, and Acrobat and Acrobat Reader DC Continuous before 15.016.20039 on Windows and OS X allow attackers to execute arbitrary code or cause a denial of service (memory corruption) via unspecified vectors, a different vulnerability
