

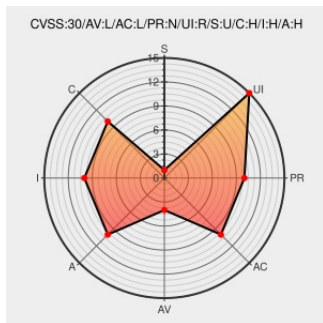

Certain versions of [Mac Os X](#) from [Apple](#) contain the following vulnerability:

Intel Graphics Driver in Apple OS X before 10.12 allows attackers to execute arbitrary code in a privileged context or cause a denial of service (memory corruption) via a crafted app.

CVE-2016-4723 has been assigned by product-security@apple.com to track the vulnerability - currently rated as **HIGH** severity.
