Certain versions of [Commentapp.stetsonwood](#) from [Commentapp.stetsonwood Project](#) contain the following vulnerability:

commentapp.stetsonwood is an http server. commentapp.stetsonwood is vulnerable to a directory traversal issue, giving an attacker access to the filesystem by placing "../" in the url.

CVE-2017-16143 has been assigned by [h1 support@hackerone.com](#) to track the vulnerability - currently rated as **HIGH** severity.
