

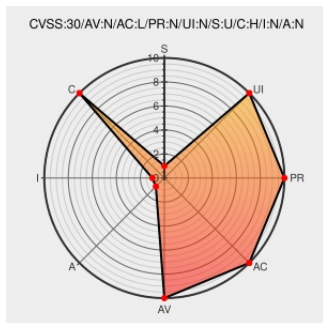

Certain versions of [Nodeaaaaa](#) from [Nodeaaaaa Project](#) contain the following vulnerability:

nodeaaaaa is a static file server. nodeaaaaa is vulnerable to a directory traversal issue, giving an attacker access to the filesystem by placing "../" in the url.

CVE-2017-16223 has been assigned by [h1](#) support@hackerone.com to track the vulnerability - currently rated as **HIGH** severity.
