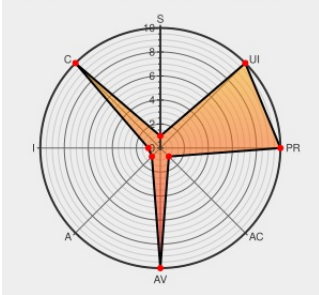

Certain versions of [21st Century Insurance](#) from [21st Century Insurance](#) contain the following vulnerability:

The 21st Century Insurance app 10.0.0 for iOS does not verify X.509 certificates from SSL servers, which allows man-in-the-middle attackers to spoof servers and obtain sensitive information via a crafted certificate.

CVE-2017-5919 has been assigned by [M](#) [cve@mitre.org](#) to track the vulnerability - currently rated as **MEDIUM** severity.
