Certain versions of [Ettokens](#) from [Ettokens Project](#) contain the following vulnerability:

The mintToken function of a smart contract implementation for ettokens (ETK), an Ethereum token, has an integer overflow that allows the owner of the contract to set the balance of an arbitrary user to any value.

CVE-2018-13160 has been assigned by [M](#) cve@mitre.org to track the vulnerability - currently rated as **HIGH** severity.
