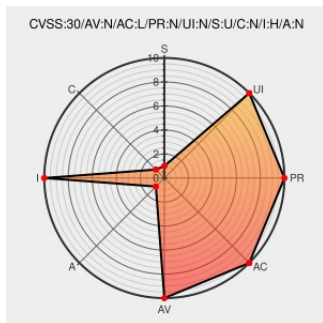

Certain versions of [Mavcash](#) from [Mavcash Project](#) contain the following vulnerability:

The sell function of a smart contract implementation for MAVCash, an Ethereum token, has an integer overflow in which "amount * sellPrice" can be zero, consequently reducing a seller's assets.

CVE-2018-13220 has been assigned by [M](#) cve@mitre.org to track the vulnerability - currently rated as **HIGH** severity.
