Certain versions of [Phantompdf](#) from [Foxitsoftware](#) contain the following vulnerability:

This vulnerability allows remote attackers to execute arbitrary code on affected installations of Foxit PhantomPDF 9.5.0.20723. User interaction is required to exploit this vulnerability in that the target must visit a malicious page or open a malicious file. The specific flaw exists within the conversion of DXF files to PDF. The issue results from the

lack of proper validation of user-supplied data, which can result in a write past the end of an allocated structure. An attacker can leverage this vulnerability to execute code in the context of the current process. Was ZDI-CAN-8773.

CVE-2019-13333 has been assigned by zdi-disclosures@trendmicro.com to track the vulnerability - currently rated as **HIGH** severity.
