

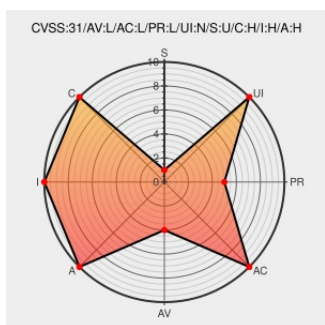

Certain versions of **6600-ap** from **Dlink** contain the following vulnerability:

An issue was discovered on D-Link 6600-AP and DWL-3600AP Ax 4.2.0.14 21/03/2019 devices. There is use of weak ciphers for SSH such as diffie-hellman-group1-sha1.

CVE-2019-14332 has been assigned by [M](#) cve@mitre.org to track the vulnerability - currently rated as **HIGH** severity.
