

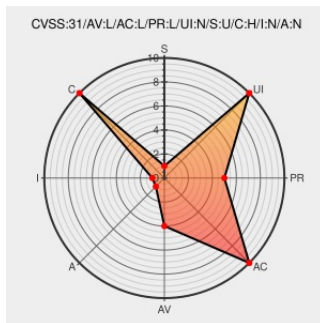

Certain versions of [Iphone Os](#) from [Apple](#) contain the following vulnerability:

An out-of-bounds read issue existed that led to the disclosure of kernel memory. This was addressed with improved input validation. This issue is fixed in iOS 12.2, macOS Mojave 10.14.4, tvOS 12.2, watchOS 5.2. A malicious application may be able to determine kernel memory layout.

CVE-2019-8510 has been assigned by product-security@apple.com to track the vulnerability - currently rated as **MEDIUM** severity.
