

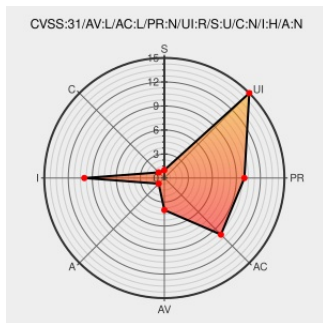

Certain versions of [Iphone Os](#) from [Apple](#) contain the following vulnerability:

This issue was addressed with improved checks. This issue is fixed in iOS 12.2, macOS Mojave 10.14.4, tvOS 12.2. A malicious application may be able to overwrite arbitrary files.

CVE-2019-8530 has been assigned by product-security@apple.com to track the vulnerability - currently rated as **MEDIUM** severity.
