

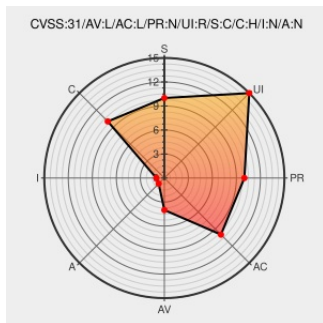

Certain versions of [Mac Os X](#) from [Apple](#) contain the following vulnerability:

An access issue was addressed with additional sandbox restrictions. This issue is fixed in macOS Catalina 10.15. A malicious application may be able to access restricted files.

CVE-2019-8855 has been assigned by product-security@apple.com to track the vulnerability - currently rated as **MEDIUM** severity.
