

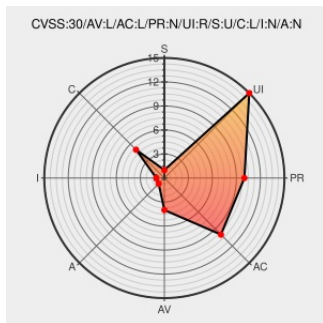

Certain versions of [Phantompdf](#) from [Foxitsoftware](#) contain the following vulnerability:

This vulnerability allows remote attackers to disclose sensitive information on affected installations of Foxit PhantomPDF 9.7.1.29511. User interaction is required to exploit this vulnerability in that the target must visit a malicious page or open a malicious file. The specific flaw exists within the handling of U3D objects in PDF files. The issue results

from the lack of proper validation of user-supplied data, which can result in a read past the end of an allocated object. An attacker can leverage this in conjunction with other vulnerabilities to execute code in the context of the current process. Was ZDI-CAN-10461.

CVE-2020-10901 has been assigned by zdi-disclosures@trendmicro.com to track the vulnerability - currently rated as **LOW** severity.
