Certain versions of [Phantompdf](#) from [Foxitsoftware](#) contain the following vulnerability:

This vulnerability allows remote attackers to execute arbitrary code on affected installations of Foxit PhantomPDF 9.7.0.29478. User interaction is required to exploit this vulnerability in that the target must visit a malicious page or open a malicious file. The specific flaw exists within the handling of the RotatePage command of the communication

API. The issue results from the lack of proper validation of user-supplied data, which can result in a type confusion condition. An attacker can leverage this vulnerability to execute code in the context of the current process. Was ZDI-CAN-9943.

CVE-2020-10910 has been assigned by zdi-disclosures@trendmicro.com to track the vulnerability - currently rated as **HIGH** severity.
