

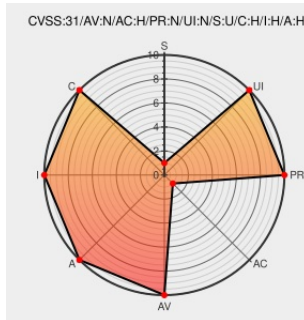

Certain versions of [Mids Reborn Hero Designer](#) from [Mids Reborn Hero Designer Project](#) contain the following vulnerability:

Mids' Reborn Hero Designer 2.6.0.7 downloads the update manifest, as well as update files, over cleartext HTTP. Additionally, the application does not perform file integrity validation for files after download. An attacker can perform a man-in-the-middle attack against this connection and replace executable files with malicious versions,

which the operating system then executes under the context of the user running Hero Designer.

CVE-2020-11614 has been assigned by [M](#) cve@mitre.org to track the vulnerability - currently rated as **HIGH** severity.
