

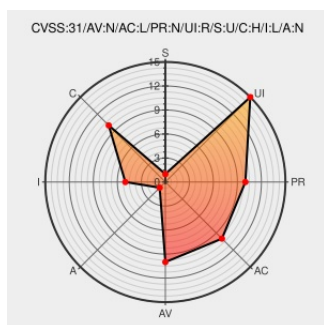

Certain versions of [Bi Publisher](#) from [Oracle](#) contain the following vulnerability:

Vulnerability in the Oracle BI Publisher product of Oracle Fusion Middleware (component: Mobile Service). Supported versions that are affected are 11.1.1.9.0, 12.2.1.3.0 and 12.2.1.4.0. Easily exploitable vulnerability allows unauthenticated attacker with network access via HTTP to compromise Oracle BI Publisher. Successful attacks require human interaction from a person other than the attacker. Successful attacks of this vulnerability can result in unauthorized access to critical data or complete access to all Oracle BI Publisher accessible data as well as unauthorized update, insert or delete access to some of Oracle BI Publisher accessible data. CVSS 3.1 Base Score 7.1 (Confidentiality and Integrity impacts). CVSS Vector: (CVSS:3.1/AV:N/AC:L/PR:N/UI:R/S:U/C:H/I:L/A:N).
