

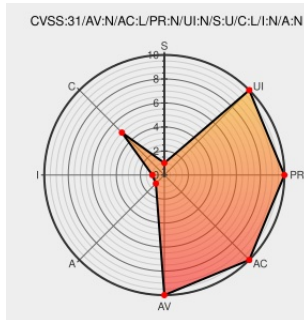

Certain versions of [Financial Services Analytical Applications Infrastructure](#) from [Oracle](#) contain the following vulnerability:

Vulnerability in the Oracle Financial Services Analytical Applications Infrastructure product of Oracle Financial Services Applications (component: Infrastructure). Supported versions that are affected are 8.0.6-8.1.0. Easily exploitable vulnerability allows unauthenticated attacker with network access via HTTP to compromise Oracle

Financial Services Analytical Applications Infrastructure. Successful attacks of this vulnerability can result in unauthorized read access to a subset of Oracle Financial Services Analytical Applications Infrastructure accessible data. CVSS 3.1 Base Score 5.3 (Confidentiality impacts). CVSS Vector: (CVSS:3.1/AV:N/AC:L/PR:N/UI:N/S:U/C:L/I:N/A:N).

CVE-2020-14604 has been assigned by secalert_us@oracle.com to track the vulnerability - currently rated as **MEDIUM** severity.
