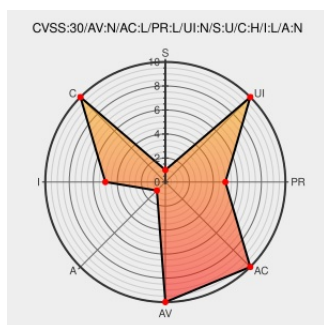

Vulnerability in the Oracle Financial Services Analytical Applications Infrastructure product of Oracle Financial Services Applications (component: Object Migration). Supported versions that are affected are 8.0.4-8.0.8. Easily exploitable vulnerability allows low privileged attacker with network access via HTTP to compromise Oracle

Financial Services Analytical Applications Infrastructure. Successful attacks of this vulnerability can result in unauthorized access to critical data or complete access to all Oracle Financial Services Analytical Applications Infrastructure accessible data as well as unauthorized update, insert or delete access to some of Oracle Financial Services Analytical Applications Infrastructure accessible data. CVSS 3.0 Base Score 7.1 (Confidentiality and Integrity impacts). CVSS Vector: (CVSS:3.0/AV:N/AC:L/PR:L/UI:N/S:U/C:H/I:L/A:N).
