

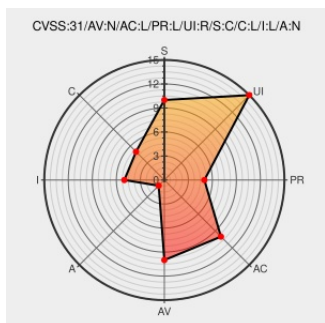

Certain versions of [Nextcloud Server](#) from [Nextcloud](#) contain the following vulnerability:

An outdated 3rd party library in the Files PDF viewer for Nextcloud Server 18.0.2 caused a Cross-site scripting vulnerability when opening a malicious PDF.

CVE-2020-8155 has been assigned by [h1](#) support@hackerone.com to track the vulnerability - currently rated as **MEDIUM** severity.
