Certain versions of [Ipados](#) from [Apple](#) contain the following vulnerability:

A memory consumption issue was addressed with improved memory handling. This issue is fixed in iOS 13.5.1 and iPadOS 13.5.1, macOS Catalina 10.15.5 Supplemental Update, tvOS 13.4.6, watchOS 6.2.6. An application may be able to execute arbitrary code with kernel privileges.

CVE-2020-9859 has been assigned by product-security@apple.com to track the vulnerability - currently rated as **HIGH** severity.
