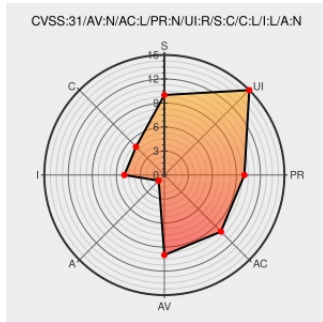

Certain versions of [Ipados](#) from [Apple](#) contain the following vulnerability:

A logic issue was addressed with improved restrictions. This issue is fixed in macOS Big Sur 11.3, iOS 14.5 and iPadOS 14.5, watchOS 7.4, tvOS 14.5. Processing maliciously crafted web content may lead to universal cross site scripting.

CVE-2021-1826 has been assigned by [product-security@apple.com](mailto:product-security@apple.com) to track the vulnerability - currently rated as **MEDIUM** severity.
