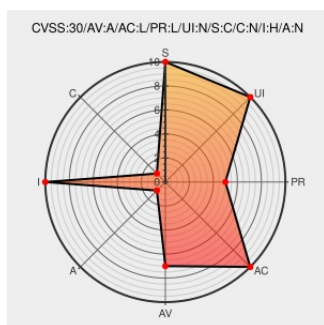

SAP Payment Engine version 500, does not perform necessary authorization checks for an authenticated user, resulting in escalation of privileges.
