

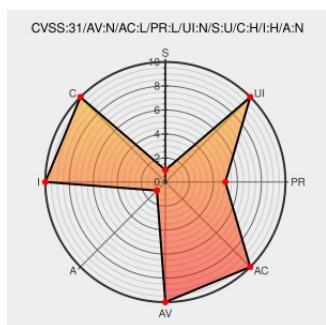

Certain versions of [Legal Entity Configurator](#) from [Oracle](#) contain the following vulnerability:

Vulnerability in the Oracle Legal Entity Configurator product of Oracle E-Business Suite (component: Create Contracts). Supported versions that are affected are 12.1.1-12.1.3. Easily exploitable vulnerability allows low privileged attacker with network access via HTTP to compromise Oracle Legal Entity Configurator. Successful attacks of

this vulnerability can result in unauthorized creation, deletion or modification access to critical data or all Oracle Legal Entity Configurator accessible data as well as unauthorized access to critical data or complete access to all Oracle Legal Entity Configurator accessible data. CVSS 3.1 Base Score 8.1 (Confidentiality and Integrity impacts). CVSS Vector: (CVSS:3.1/AV:N/AC:L/PR:L/UI:N/S:U/C:H/I:H/A:N).

CVE-2021-2273 has been assigned by secalert_us@oracle.com to track the vulnerability - currently rated as **HIGH** severity.
