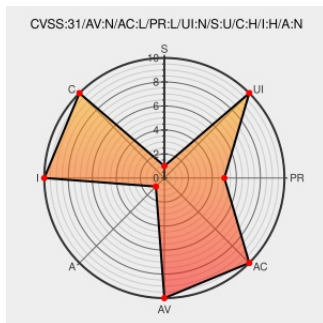

Certain versions of **Public Sector Financials** from **Oracle** contain the following vulnerability:

Vulnerability in the Oracle Public Sector Financials (International) product of Oracle E-Business Suite (component: Authorization). Supported versions that are affected are 12.1.1-12.1.3. Easily exploitable vulnerability allows low privileged attacker with network access via HTTP to compromise Oracle Public Sector Financials

(International). Successful attacks of this vulnerability can result in unauthorized creation, deletion or modification access to critical data or all Oracle Public Sector Financials (International) accessible data as well as unauthorized access to critical data or complete access to all Oracle Public Sector Financials (International) accessible data. CVSS 3.1 Base Score 8.1 (Confidentiality and Integrity impacts). CVSS Vector: (CVSS:3.1/AV:N/AC:L/PR:L/UI:N/S:U/C:H/I:H/A:N).

CVE-2021-2363 has been assigned by secalert_us@oracle.com to track the vulnerability - currently rated as **HIGH** severity.
