

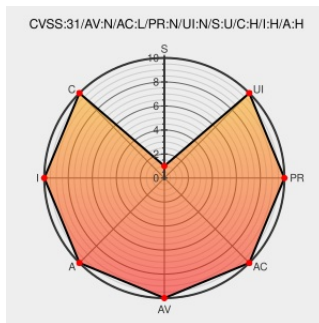

Certain versions of [Money Transfer Management System](#) from [Money Transfer Management System Project](#) contain the following vulnerability:

Money Transfer Management System Version 1.0 allows an unauthenticated user to inject SQL queries in 'admin/maintenance/manage_branch.php' and 'admin/maintenance/manage_fee.php' via the 'id' parameter.

CVE-2022-25222 has been assigned by help@fluidattacks.com to track the vulnerability - currently rated as **CRITICAL** severity.
