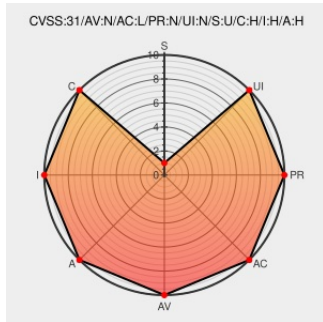

Certain versions of [Wnr2000v4](#) from [Netgear](#) contain the following vulnerability:

Netgear N300 wireless router wnr2000v4-V1.0.0.70 is vulnerable to Buffer Overflow via uhttpd. There is a stack overflow vulnerability caused by strcpy.

CVE-2022-37232 has been assigned by [M](#) [cve@mitre.org](mailto:cve@mitre.org) to track the vulnerability - currently rated as **CRITICAL** severity.
