Description	The Restaurant Menu – Food Ordering System – Table Reservation plugin for WordPress is vulnerable to Cross-Site Request Forgery (CSRF) via the table reservation endpoint. An attacker can bypass the CSRF protection by using a crafted request that includes a valid CSRF token. This allows the attacker to perform actions on behalf of the user, such as creating a new reservation or modifying an existing one.
