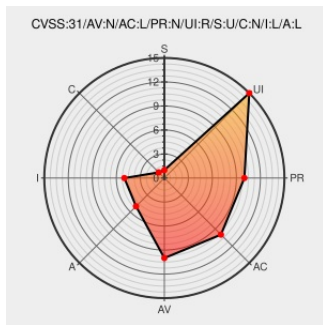

Cross-Site Request Forgery (CSRF) vulnerability in SedLex Favlon Switcher plugin <= 1.2.11 at WordPress allows plugin settings change.

CVE-2022-40219 has been assigned by audit@patchstack.com to track the vulnerability - currently rated as **MEDIUM** severity.
