

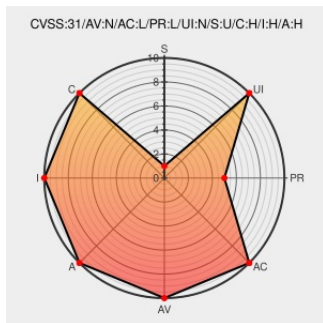

Certain versions of [Wedding Planner](#) from [Wedding Planner Project](#) contain the following vulnerability:

Wedding Planner v1.0 was discovered to contain an arbitrary file upload vulnerability in the component `/admin/users_add.php`. This vulnerability allows attackers to execute arbitrary code via a crafted PHP file.

CVE-2022-41539 has been assigned by [M](#) cve@mitre.org to track the vulnerability - currently rated as **HIGH** severity.
