

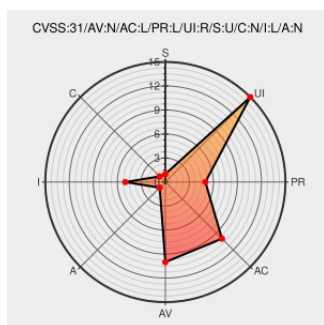

Certain versions of [Delete Log](#) from [Jenkins](#) contain the following vulnerability:

A cross-site request forgery (CSRF) vulnerability in Jenkins Delete log Plugin 1.0 and earlier allows attackers to delete build logs.

CVE-2022-45393 has been assigned by [jenkinsci-cert@googlegroups.com](#) to track the vulnerability - currently rated as **LOW** severity.
