

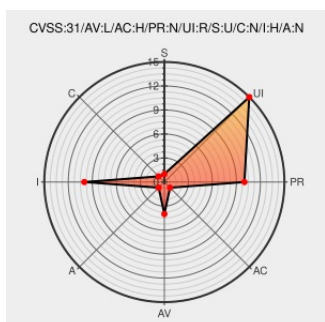

Certain versions of [Macos](#) from [Apple](#) contain the following vulnerability:

A race condition was addressed with improved locking. This issue is fixed in macOS Sonoma 14. An app may be able to modify protected parts of the file system.

CVE-2023-41979 has been assigned by product-security@apple.com to track the vulnerability - currently rated as **MEDIUM** severity.
