<b>Description</b>	The Easy Social Feed – Social Photos Gallery – Post Feed – Like Box plugin for WordPress is vulnerable to Stored Cross-Site Scripting (SSRF) via the shortcode. An authenticated contributor can trigger the SSRF by providing a specially crafted shortcode. This can be used to access internal network resources, including databases and administrative interfaces.
