Description	The Post and Page Builder by BoldGrid – Visual Drag and Drop Editor plugin for WordPress is vulnerable to Stored Cross-Site Scripting (XSS) via its 'Contributer+' user role. An authenticated user with this role can inject malicious JavaScript code into the page content, which is then rendered to all users. This vulnerability affects versions of the plugin up to and including 1.26.4.
