<b>Description</b>	The FloristPress for Woo – Customize your eCommerce store for your Florist plugin for WordPress is vulnerable to Reflected Cross-Site Scripting (XSS) via the 'noresults' parameter. An attacker can inject arbitrary HTML and JavaScript code into the page output, which is then rendered by the browser. This can lead to session hijacking, account takeover, and other malicious activities.
