<b>Description</b>	The Gutenverse – Ultimate WordPress FSE Blocks Addons & Ecosystem plugin for WordPress is vulnerable to Stored Cross-Site Scripting (XSS) via the 'separatorIconSVG' parameter in the 'separatorIconSVG' endpoint. An authenticated user (Contributor+) can trigger this vulnerability by submitting a malicious payload through the 'separatorIconSVG' parameter. This results in the execution of arbitrary JavaScript code within the context of the affected WordPress site.
